

PATHWAY AGREEMENT FOR HIGH SCHOOLS, CAREER TECHNOLOGY CENTERS (CTC), AND CAREER & TECHNICAL EDUCATION (CTE) SENDING INSTITUTIONS BETWEEN

PENNSYLVANIA COLLEGE OF TECHNOLOGY

AND

YORK COUNTY SCHOOL OF TECHNOLOGY

This pathway agreement establishes a mechanism for students of York County School of Technology to earn credit for the below defined coursework at Penn College in the Diesel Technology (A.A.S), Heavy Construction Equipment Technology: Technician Emphasis (A.A.S.), Heavy Construction Equipment Technology: Caterpillar Emphasis (A.A.S.), Electric Power Generation: Diesel Emphasis (A.A.S.), and Heavy Construction Equipment Technology: Operator Emphasis (A.A.S.) majors.

Additional Transfer Information

- Students must have gained admission to Penn College and met placement requirements.
- Penn College will accept York County School of Technology coursework for Penn College credit for students who enroll at the College within two (2) academic years of graduation from York County School of Technology.
- Students must complete coursework with a grade of C or better (2.0 or better on a 4.0 scale).
- Students must submit their final official York County School of Technology transcript to Penn College prior to enrollment in order to receive credit for their York County School of Technology coursework.
- Penn College will only consider those credits earned through York County School of Technology for the terms of this agreement. Students must request transcripts from additional institutions to be evaluated on an individual basis at Penn College.
- Credits will post on the student’s official academic transcript upon the successful completion of twelve (12) credits of academic work at Penn College. Whether Penn College credits will be accepted by another college or university is at the discretion of the receiving college or university.
